

It was a pleasure to attend the Newly Elected Officers Training School in Rochester on January 17 – 19 with Vivian Cunningham a newly elected town board member. Vivian and I came away with many new insights, and an appreciation for the fine job our predecessors have done.

We want to express our appreciation to Howard Nelson for his fine service to the community over the past four years. We appreciate the highway crew for doing a fine job of keeping our roads accessible for winter travel. The have spent many days on the road by 4 AM in preparation for everyone's early morning commutes, along with making their last run sometimes ending after 7 PM. Thanks to Mark, Tim, Bill, John and Tom!

Our spring cleanup day is scheduled for May 5th. We always welcome any help from residents to aid our neighbors in unloading their loads of debris, which have accumulated over the winter. Remember, this is a special service which we offer town residents and not to everyone with a Scipio Center address.

This year we will be offering Wednesday evening recycling hours from 5 to 8 PM during the months of May through September in addition to our regular Saturday hours. This will allow residents to take advantage of this service and be able to enjoy the weekend without having to wait for Saturday hours.

We will be having a public hearing on May 9, 2018 to discuss two new local laws. The first is to allow the Code Enforcement Officer to be appointed from outside our town while the second is to have a tighter electioneering law. From Cayuga County Legislator Keith Batman: 2017 was a productive year in the Cayuga County Legislature. As Chair of the Legislature in 2017, I had the opportunity and pleasure to work with other Legislators and County staff to accomplish a number of important initiatives. We developed and passed a balanced budget for 2018, which holds taxes below the NYS imposed tax by almost a full percent. We did this without layoffs or cuts in services and with the addition of some critical positions and initiatives by focusing on efficiencies and County wide priorities. Our environmental initiatives include the designation as a green community by NYSERDA, which enabled us to receive a \$250,000.00 grant to promote energy efficiency and will support the development of a strategic plan for the County Power Authority. Reducing our energy foot print, developing solar and other energy saving initiatives are ongoing projects.

In the critical area of water quality, we continue our work with local officials, staff, and State officials to deal with toxins in Owasco Lake and hydrilla infestation in Cayuga Lake. The Water Quality Management Agency completed recommendations for road side ditch maintenance and sedimentation issues to reduce off into the lakes. The Owasco Lake Rules and Regulations group was formed to refresh Owasco Lake Watershed regulations, and efforts continue to develop solutions to the critical water treatment issues in the Village of Aurora. With the hope of tying these efforts together the Cayuga County Water and Sewer Authority will complete a County wide investigation of water sewer issues in 2018.

Our administrator left in early 2017 and we spent time as a legislature, along with department heads, thinking about and attempting to understand why we have such a high turnover in this critical position. As a result, we developed a new framework for the position which I certainly hope will go a long way toward creating stability in this position. After rethinking the position, we hired Justin Woods as the new Cayuga County Administrator. He is on the job providing solid policy leadership and day to day management.

From Highway Superintendent Mark Chamberlain: After dealing with the up and down temperatures this winter the highway department is getting ready and gearing up for the upcoming spring season.

We will be paving approximately two and a half miles of town roads this upcoming season as well as ditching throughout the town, so if anyone is interested in ditch dirt you can call the town barn at (315) 364-7754 and leave a message. Please clearly state your name, phone number and address and I will get back to you.

We also have a large pile of wood chips behind our town barn which residents are free to come and help their selves.

From Town Clerk Tom Olenych: The town is looking to appoint someone as deputy town bookkeeper to assist and or fill in for the town's bookkeeper in the event she is away for any reason. This is a paid position, and anyone interested can contact me at the town offices (315) 364-5740.

Lastly, I want to urge everyone to take the time to make a visit to the Cayuga County DMV in the county office building when ever possible.

I say this, and this just came to my attention, because for every dollar the Cayuga County DMV collects in person 12.7% of that money stays in Cayuga County. This in turn helps keep our taxes down. If you use the internet to do any DMV transactions nothing, zero, zip stays in Cayuga County. It's less convenient than the internet but the difference it makes to the citizens of Cayuga County is significant.

March 1st. ALL EXEMPTION APPLICATIONS ARE DUE FOR THE UPCOMING 2018 ASSESSMENT ROLL. All exemption applications received after March 1, 2018 will be processed for the 2019 Assessment Roll.

March 1, 2018 Taxable Status Date: Property will be assessed as it stands today.

March – April 2018: Office Hours, property visits and valuation review call (315) 806-5500 to schedule an appointment.

May 1, 2018: Tentative Assessment Roll is available at the Town Offices and on the Cayuga County Real Property website. Change of Assessment Notices are mailed.

May 2018 dates and times of "Sitting with the Roll" to be determined and posted in April. Be sure to bring photos, photocopies of appraisal, survey, parcel sales listing, comparable sales (2010-2016) or any other evidence that supports the full market value of your property.

May 31st. Board of Assessment Review is scheduled to hear assessment grievances from 4:00 PM to 8:00 PM at the town offices.

June: Office hours and property visits by appointment only.

July 1, 2018: Final 2018 Assessment Roll filed and available at the town offices and Cayuga County website.

July & August: Office hours and property visits by appointment only. Call me to schedule an appointment.

***** **ONLY EVIDENCE** can be considered while reexamining the Assessed Value of a property. If you plan to meet with me or with the BOARD OF ASSESSMENT REVIEW be sure to bring photos, photocopies of appraisal, survey, parcel sales listings, comparable sales (2010-2016) or any other evidence that supports the full market value of your property. *****
